## LOCATION

Northfield is a busy Birmingham suburb located approximately 8 miles to the South West of the city centre. Phase II of the centre is planned to be redeveloped and replaced with a supermarket with a surface car park.

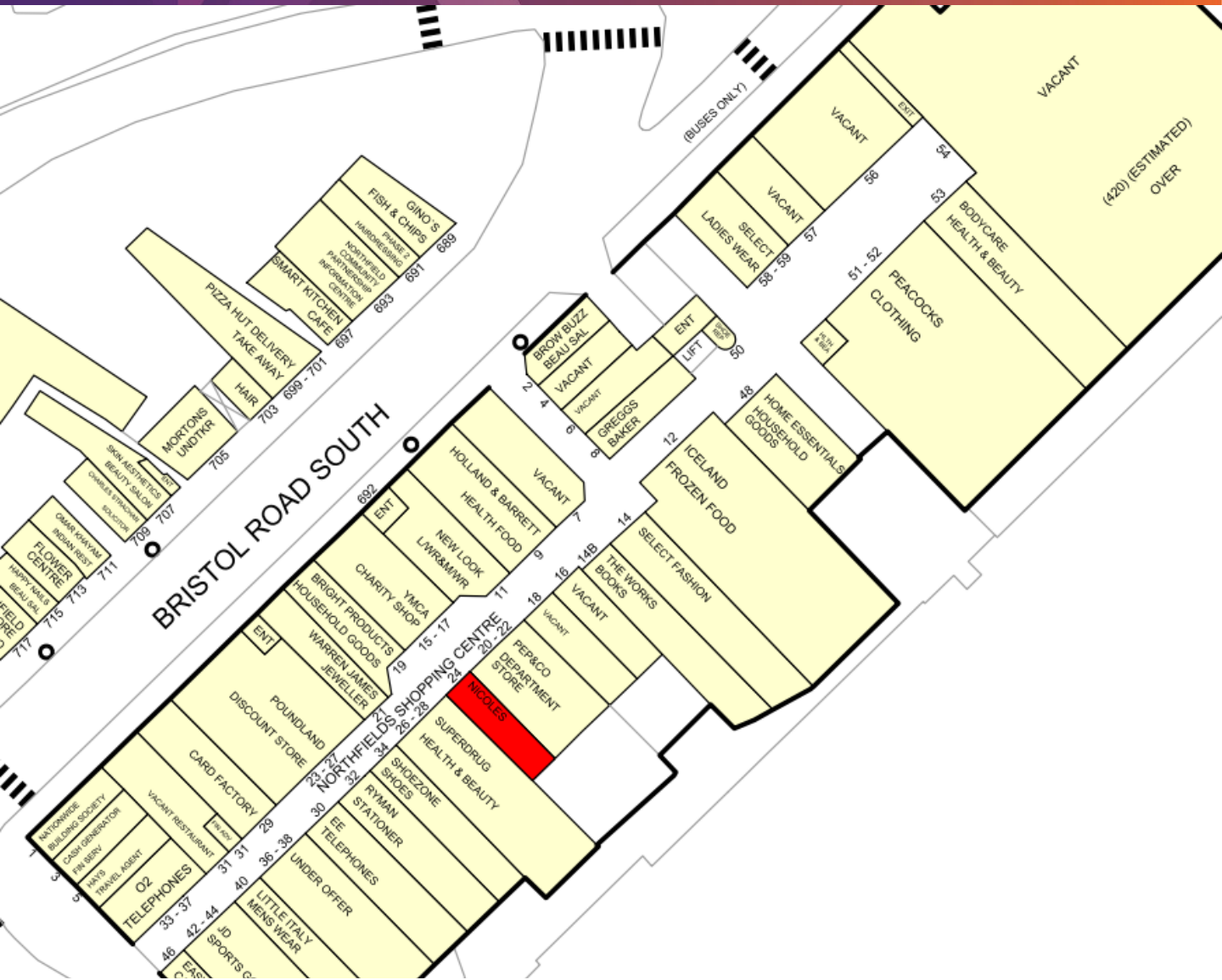
